RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

STEP 1

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale service.

(I) **RATES** (Customers with metered water supply)

First	3,000 gallons used per month	\$12.75 per 1,000 gallons
Next	3,000 gallons used per month	\$12.23 per 1,000 gallons
Next	3,000 gallons used per month	\$11.79 per 1,000 gallons
Next	6,000 gallons used per month	\$11.41 per 1,000 gallons
Next	22,500 gallons used per month	\$ 9.74 per 1,000 gallons
All Over	37,500 gallons used per month	\$ 8.83 per 1,000 gallons

(I) **MINIMUM CHARGE**

No bill will be rendered for less than the following, based on meter size:

5/8 inch meter	\$ 38.25 per month
1 inch meter	\$ 95.63 per month
1- 1/2 inch meter	\$ 191.25 per month
2 inch meter	\$ 306.00 per month
3 inch meter	\$ 612.00 per month
4 inch meter	\$ 956.25 per month
6 inch meter	\$ 1,912.50 per month
8 inch meter	\$ 3,060.00 per month

(I) **TRANSPORTATION RATE**

\$0.48 per 1,000 gallons

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed penalty is not interest and is to be collected only once for each bill where it is appropriate.

STEP 1 (Continued)

TAP FEE

The following charges are to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$50.00 will be charged to customers applying for service before construction is completed adjacent to the customer's premises in connection with a certificate proceeding before the Commission. This pre-construction tap fee will be invalid after the completion of construction adjacent to an applicant's premises that is associated with a certificate proceeding.

A tap fee of \$450.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

(I,C) **PRIVATE FIRE PROTECTION**

\$60.55 per month on all unmetered private fire service connection lines.

RECONNECTION

\$25.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

(I) **LEAK ADJUSTMENT**

\$4.87 per 1,000 gallons is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.
