

- I. Rules and Regulations for the Government of Sewerage Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

STEP 1 RATES

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial, and industrial service.

(I) **RATES** *

\$19.41 per thousand gallons of water used per month.

(I) **FLAT RATE CHARGE** *

Equivalent of 4,500 gallons of water usage: \$87.35 per month.

MINIMUM CHARGE *

No bill will be rendered for less than: \$33.58 per month.

- (I) The above minimum charge is subject to an additional \$2.62 per thousand gallons of water used per month.

RETURNED CHECK CHARGE

A service charge equal to the bank fee assessed to the sewer utility, not to exceed \$25.00, will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

DISCONNECT/RECONNECT/ADMINISTRATIVE FEES

Whenever water service has been disconnected for non-payment of sewer bills in conjunction with a water service termination agreement with the City of Clarksburg, a disconnect fee of \$20.00 shall be charged; or in the event a delinquent sewer bill is collected by the water company, an administrative fee of \$20.00 shall be charged.

Whenever water service, which has been previously disconnected or otherwise withheld for non-payment of a sewer bill in conjunction with a water service termination agreement with the City of Clarksburg, is reconnected, a reconnection fee of \$20.00 shall be charged.

DELAYED PAYMENT PENALTY *

The above payment is net. On all accounts not paid in full when due, ten percent will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to customers applying for service outside of a certificate proceeding before the Commission for each new tap to the system.

(I) LEAK ADJUSTMENT *

\$7.56 per 1,000 gallons of water is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above 200% of the customer's historical average water usage.

(C) SECURITY DEPOSIT

Not to exceed two times the average monthly bill for the applicant's specific customer class or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

(D) * 6.08% CASH WORKING CAPITAL RESERVE INCREMENT

6.08% of total billings at the indicated rates is required to be recorded as a credit to "Miscellaneous Operating Reserves", with related collections to be charged to "Other Special Funds" and deposited into a distinct CWCR Bank Account.



MINIMUM CHARGE *

No bill will be rendered for less than: \$33.58 per month.

RETURNED CHECK CHARGE




